Dear Clubs

I would like to advise that the NWSF Board has reviewed the budget for the 2024 Winter season and has set Winter Registration fees as per the attached scheduled.

Unfortunately, we have seen increased costs passed on from Football NSW (by up to as much as \$19 per player in some instances) as well as the continued increase in inflationary pressures on the Australian economy, and the rising costs associated with running the association. We have already seen significant costs increases in field & light hire, insurance, electricity, and other amenities. We have made every attempt to keep the cost of playing football to a minimum, but due to external factors beyond our control NWSF has been forced to raise player registration fees for the 2024 Winter Football Season. The total fee increases are highlighted below:

Juniors (U6-U12) \$9.50 fee increase on 2023
Youth (U13-18) \$10.50 increase on 2023
Seniors (U19 +) \$27 increase on 2023

As mentioned above, Football NSW have also increased their component of fee
